Jose Celso Barbosa: Letter from NY College of Physicians and Surgeons (Columbia) 1877

DEAR SIR, – At a faculty meeting held last night it was decided not to receive students of color. I report that under this resolution Mr. Barbosa will be unable to matriculate here.

 the brains in the cranium."





• "In 1880 the candidate who received the highest number of votes, fifty-one out of a possible fifty-six, and thus graduated at the head of his class was Dr. José Celso Barbosa of San Juan, Puerto Rico, the first student to come to the University from that island. One of the youngest graduates was Dr. William J. Mayo, who lacked one day of being twenty-two at the time of his graduation in 1883."

- Service as an excellent physician in PR: medal of honor
- Service under US appointed governors, member of the first senate under US rule
- Founder of first bilingual newspaper in PR
- Founder of the pro-statehood movement in PR
- Creator of laws establishing employer-based health insurance in PR
- Holiday in PR celebrates his birthdate on July 27.

RACE RELATED CANCER DISPARITIES VS SES-BASED DISPARITIES

- Prejudice is not limited to race
- What are our diversity goals? A society where everyone is respected and provides equal educational opportunities to all
- What should be our ultimate goal? Achieving health equity
- As a society, we need to fight for access to healthcare as a human right
- In our capitalist system, the medical industry (health systems, pharma, insurance companies) goals may not perfectly align with what is best for the health of our communities or individual patients.


SIRE (SELF IDENTIFIED RACE AND ETHNICITY)

- Race and ethnicity is a multi dimensional social construct that reflects how the individual perceives themselves as well as how they are perceived by others
- Race/ethnicity is a social construct, not a biological construct
 - Race changes based on who is making the assignment
 - Racial health disparities vary depending on gradients of skin color
- Genetic ancestry versus SIRE


